

249 Acres of Urban Greenspace Protected in 2008

Bringing total urban acres to 437

During the second year of the program, two municipalities and three non-profit organizations received funding from Charleston County's Urban Greenbelt Program. Charleston County Council approved 15 urban greenbelt projects, which resulted in the following:

- ♦ 249 acres provided for urban parks and greenspace
- ♦ \$5.7 million in urban funds awarded
- ♦ \$22,637 cost per acre
- ♦ \$5.5 million in match

- 179 acres toward the urban greenbelt land goal of 2,000 acres
- ♦ 258 acres toward the wetlands goal of 5,610 acres





In accordance with the Comprehensive Greenbelt Plan, urban funds are allocated to the municipalities and unincorporated areas according to the population of each.

This chart shows each municipality's allocation, acreage of approved projects, awarded funding, and the funds remaining.

The unincorporated funds were awarded to:

- Four Mile Community (\$269,950)
- Calvary AME Church (\$565,000)
- Phillips Community (\$210,000)

About the Urban Greenbelt Program

The Charleston County Comprehensive Greenbelt Plan established an Urban Grants Program to distribute the Greenbelt portion of the Transportation Sales Tax proceeds in the form of financial grants to urban areas of the County. The purpose of the grants is to distribute funding in an equitable manner for the conservation of greenspace.

Urban greenbelt lands contain the greatest population density and intensity of development, as well as the greatest concentration of jobs and economic activity. Conservation of greenspace for various uses is crucial in offsetting the negative impacts of increased density. Typical uses for urban greenbelt lands include urban parks, cultural/historic sites, reclaimed greenspace, greenway corridors and water access.
